

## Directions to Envisian

12 Mystic Lane, Chester County Commons, Malvern, PA 19355 (610) 640-4600

(near the intersection of Lancaster Avenue and Phoenixville Pike in Frazer near Home Depot)

### FROM PENNSYLVANIA TURNPIKE

- Take Turnpike east from Harrisburg or west.
- Exit at Exit 23 (Downingtown/Exton). Bear left under underpass onto Route 100 South.
- Go South on Rt. 100 to Route 30 (Exxon on left, Denny's opposite right).
- Turn left onto Route 30. Travel east for about five minutes past Church Farm School, under Route 202, and look for Home Depot on right.
- Turn right at the next light onto Phoenixville Pike. Go about 150 feet and make first left into Chester County Commons.
- We are on the right side of the complex in #12. The front door is in the center courtyard.

### FROM PHILADELPHIA/KING OF PRUSSIA

- Take I-76 (Schuylkill Expressway) west to King of Prussia. Exit for Rt. 202 South (Exit 26B). Follow 202 South past Paoli, Chesterbrook, Great Valley, Rt. 401, to Rt. 30 East/Frazer exit.
- Exit at Rt. 30 East (Frazer) and turn left at the light. Proceed up the hill, past Home Depot.
- At the next light, turn right onto Phoenixville Pike.
- Go about 150 feet and make first left into Chester County Commons.
- We are on the right side of the complex in #12. The front door is in the center courtyard.

### FROM WEST CHESTER

- **Option 1:** Take Route 202 North to Rt. 30 Frazer. At the light. turn right. Go past Home Depot on your right. At the next light, turn right onto Phoenixville Pike.
- Go about 150 feet and make the first left into Chester County Commons.
- We are on the right side of the complex in #12. The front door is in the center courtyard.
- **Option 2:** Take Phoenixville Pike north, remembering that it jogs to the right for a short distance when it crosses King Road. Follow Phoenixville Pike past Home Depot on your left, almost to its intersection with Rt. 30. Turn right into Chester County Commons. We are on the right side of the complex in #12. The front door is in the center courtyard.

### FROM PAOLI/MAIN LINE AREA

- Take Rt. 30 east through Frazer. Look for Walton Furniture on your left. Turn left at the light onto Phoenixville Pike, just before Home Depot.
- Go about 150 feet and make first left into Chester County Commons.
- We are on the right side of the complex in #12. The front door is in the center courtyard.

### FROM DOWNINGTOWN/WEST

- Take Exton Bypass going east toward Frazer. Continue to the end and exit where it connects with Frazer/Route 30 near the Sheraton Great Valley.
- At the exit, make a right and continue east on Rt. 30. Look for Home Depot.
- At the next light, make a right at light onto Phoenixville Pike.
- Go about 150 feet and make first left into Chester County Commons.
- We are on the right side of the complex in #12. The front door is in the center courtyard.
